IN DECEMBER 2016, TWO NEW ENTITIES WERE FORMED, UZIMA CLEAN WATER MISSIONS, LLC ("UCWM") AND UZIMA FILTERS, LLC ("NEW UZIMA"). IMMEDIATELY UPON UCWM'S FORMATION, "OLD UZIMA" WAS MERGED INTO "UCWM." AS OF 1 JANUARY 2017, SWOI BECAME THE SOLE MEMBER OF THE TWO NEWLY CREATED LIMITED LIABILITY COMPANIES. AS A LIMITED LIABILITY COMPANY WHOSE SOLE MEMBER IS SWOI, UCWM IS TREATED FOR TAX PURPOSES A DISREGARDED ENTITY, AND AS SUCH SWOI'S TAX-EXEMPT STATUS IS APPLICABLE TO UCWM. FOR PRESENTATION PURPOSES, UCWM IS CONSOLIDATED WITH SWOI, AND INTER-ORGANIZATIONAL TRANSACTIONS ARE ELIMINATED. "NEW UZIMA" WAS FORMED AS A WHOLLY OWNED SUBSIDIARY OF SWOI, TARGETING SALES OF CLEAN WATER FILTERS TO THE RETAIL MARKET. FOR TAX PURPOSES, "NEW UZIMA" INTENDS TO BE TREATED AS A CORPORATION. IT MAY BE SUBJECT TO UNRELATED BUSINESS INCOME TAXES AND OTHER TAXES AS A RESULT OF ITS ACTIVITIES IN THE RETAIL MARKET. AS OF THIS TIME, "NEW UZIMA" HAS HAD NO ACTIVITY.
